## NOTICE OF VACANCY

**Interested persons are hereby notified that a vacancy exists on the  
Alto Sanitary District Board of Directors**

**Would you like to be an environmental steward for your community? Do you want an active role in local government?** We are looking for a neighbor who wants to ensure that the residents of the Alto Sanitary District, aka Horse Hill and Bay View Terrace, receive a high-quality, serviceable collection system for transporting sewage from our homes and businesses to the Sewerage Agency of Southern Main (SASM) wastewater treatment plant. This essential service is overseen by a board of directors who meet on the fourth Wednesday of every month at 7:30pm for about an hour and receive \$125 per meeting to review operations, update policies, verify compliance with State and Federal regulations, and plan for future needs. The board is composed of five individuals who live within the District limits. A vacancy exists for one of the five seats to complete the remaining term of Tania Kennedy, who served the district for many years.

The current commitment is only through November 2024 when the seat will be up for election again. This is a great opportunity to learn about the most basic government service you use every day and take for granted until there is a problem. The history of sewer systems dates back to 4000 BC but we are still working to improve them. Here in the Alto Sanitary District, many aging mains and the laterals that connect the houses to them are in need of repair. Using approved funding, the District is actively implementing a repair and replacement schedule over the next ten years so that the system will last and be environmentally stable. You will also help oversee the District's recycling program and aid in public info on the proper disposal of hazardous waste.
