

**RESOLUTION NO. 2016 - 03
OF THE BOARD OF DIRECTORS OF
THE ALTO SANITARY DISTRICT**

**A RESOLUTION OVERRULING PROTESTS TO AND CONFIRMING ADOPTION OF ORDINANCE
2016 – 01 ESTABLISHING SEWER USER SERVICE CHARGES FOR ALTO SANITARY DISTRICT
FOR THE FISCAL YEAR 2016-2017**

RESOLVED, by the Board of Directors of the Alto Sanitary District, Marin County, California, that:

WHEREAS, this Board adopted Ordinance No 2016 – 01: AN ORDINANCE ESTABLISHING THE RATE OF THE ANNUAL SEWER SERVICE CHARGE LEVIED ON IMPROVED PROPERTIES IN THE DISTRICT providing for the Collection of Sewer Service Charges for the Fiscal Year 2016-2017;

WHEREAS, this Board fixed the time and place of hearing protests to the proposed increase of SEWER USER SERVICE CHARGES and adoption of said Ordinance and directed that notice thereof be given;

WHEREAS, notice of the time and place of said hearing was given in the manner provided by law as appears by the affidavit of publication on file in the office of the Manager of said District and by the Declaration of Service By Mail on the document entitled “NOTICE OF PUBLIC HEARING, PROPOSED INCREASE OF SEWER SERVICE CHARGE served on the owners of record of all properties situated within the Alto Sanitary District;

WHEREAS, said matter came on regularly for hearing at the time and place fixed; and

WHEREAS, all written protests and other written communications were reviewed by the board and available at said meeting for public review and all persons desiring to be heard were fully heard;

NOW, THEREFORE, IT IS ORDERED, as follows:

1. That objections to and protests against said Ordinance were not made by the owners of a majority of the separate parcels of property against which charges for the services and facilities provided by the District were fixed.
2. That all objections to and protest against said Ordinance have been heard by the Board and that said objections and protest be, and each of them is hereby, overruled.
3. That said Ordinance No. 2016 - 01 is hereby, adopted in full without revision, change, reduction or modification of any charge specified within, and that said charges shall be collected on the tax roll of the County of Marin, in the manner provided by law.
4. That the Manager of the District be, and is hereby, directed to file with the County Auditor of Marin County, on or before the 10th day of August, 2016 a copy of said Ordinance, upon which shall be endorsed over his signature a statement that the Ordinance has been finally adopted by the Board of Directors of the Alto Sanitary District.
5. The County Auditor-Controller of Marin County shall, upon receipt of said report, enter the amounts of the charges against the respective lots of parcels as they appear on the assessment roll for the Fiscal Year 2016-2017.
